Vertex Library Product EULA (End User License Agreement)

1. DEFINED TERMS

1.1. "Product" means the textures, materials, renders, 3D models and geometry, documentation, data and related resources offered by Vertex Library.

2. YOUR ACCEPTANCE OF TERMS

- 2.1. The following Agreement is between you (the end user of the Product, individual or employee) and Vertex Library and constitutes a legal agreement that governs your use of the Product and is not an agreement for sale. You must agree to the terms of this Agreement before you can use the Product. If you do not agree to any of the following terms, please do not use the Product. You should print or otherwise save a copy of this Agreement for your records.
- 2.2. By accepting this Agreement you represent that you understand and agree to the foregoing.

3. LICENSE AGREEMENT

- 3.1. The Starter Edition License grants commercial usage rights of the Product for one user, such as an independent freelancer or enthusiast.
- 3.2. The Pro Edition License grants commercial usage rights of the Product for one user, such as an independent freelancer or enthusiast.
- 3.3. The Complete Edition License grants commercial usage rights of the Product for one user, such as an independent freelancer or enthusiast.
- 3.4. The Studio Edition License grants commercial usage rights for an unlimited number of users within the premises of a single company or legal entity.
- 3.5. Any commercial usage rights granted to Licensee are not granted to any affiliate companies, outsourcing partners, subsidiaries and/or entities that share the name but not the location of the parent entity. Notwithstanding anything to the contrary in this Agreement, Licensee subcontractors working on location of Licensee are granted usage rights, provided Licensee holds an active commercial License to the Product.
- 3.6. Vertex Library grants to Licensee a non-exclusive, non-transferable, non-refundable permanent License to use the Product. Vertex Library will provide the Product via the internet in a commercially reasonable manner.
- 3.7. Any part of the Product, including content and/or documentation that is downloaded by Licensee is allowed to be used locally and perpetually, and may be incorporated into any number of media projects (including but not limited to animations, games, visualisations and movies). Licensee is granted full commercial usage rights with a perpetual commercial License for the Product.

- 3.8. Licensee agrees that it may not resell, assign, publish, rent, lease, lend or otherwise redistribute the Product or any of its included files without prior written consent from Vertex Library. Using the Product or any included content for the purpose of a selling a commercial asset or resource pack, or any similar product is strictly forbidden.
- 3.9. The email address supplied when purchasing the Product will be used for all official communication with Vertex Library, but may be subject to change as required by Vertex Library.
- 3.10. As part of the Product, the Licensee may from time to time receive updates to the Product from Vertex Library. These updates may include additional content, bug fixes, feature additions and entirely new versions of the Product.
- 3.11. Licensee agrees that it will not use the Product to: engage in any copyright infringement or other intellectual property infringement, or disclose any trade secret or confidential information in violation of a confidentiality, employment, or nondisclosure agreement; post, send, transmit or otherwise make available any unsolicited or unauthorized email messages, advertising, promotional materials, junk mail, spam, or chain letters, including, without limitation, bulk commercial advertising and informational announcements; plan or engage in any illegal activity.
- 3.12. Licensee agrees that it may not share unmodified parts of the Product with external parties including but not limited to outsourcers, freelancers, clients and online resources. Licensee may only share content made with the Product to external parties provided that Licensee has been granted full commercial usage rights of the Product and that the data is in a reasonably modified state, and that the external party 1) works on the same project, or 2) holds an active commercial License for the Product.

4. OWNERSHIP

- 4.1. Vertex Library owns all legal right, title and interest in and to the Product, including any and all intellectual property rights that exist therein, whether registered or not, and wherever in the world they may exist. Licensee further agrees that the Product may contain proprietary and confidential information that is protected by applicable intellectual property and other laws.
- 4.2. Licensee owns all legal rights in any software or content it develops that incorporates the Product, including without limitation, games, animations, films, visualisations and images. All rights, title and interest, intellectual property and exclusive exploitation rights to content produced by Licensee using the Product, are in Licensee's full ownership, on a worldwide basis and for the duration of the rights (including extensions, reversions, revivals and renewals of the same and thereafter, to the fullest extent possible, in perpetuity) in each country. Licensee may provide modified parts of the Product to third parties as part of Licensee's providing services and/or content to such third parties, and the third parties shall be free to use the Licensee-developed content (which may include elements of the Product) without any limitation or obligation whatsoever to Vertex Library.

5. COPYRIGHT

- 6.2. Vertex Library warrants that the Product will be without watermarks or other impediments to the uses contemplated under this Agreement.
- 6.3. You understand and acknowledge that the Product is made available on an "AS IS" basis. Except for the warranties expressly stated in this Agreement, Vertex Library disclaims all warranties of the Product, expressed or implied. LICENSEE ASSUMES ALL RISKS AND ALL COSTS ASSOCIATED WITH YOUR USE OF THE PRODUCT, INCLUDING, WITHOUT LIMITATION, ANY BACK-UP EXPENSES, COSTS INCURRED FOR THE USE OF YOUR DEVICE AND PERIPHERALS, AND ANY DAMAGE TO ANY EQUIPMENT, SOFTWARE, INFORMATION OR DATA. In addition, Vertex Library is not obligated to provide any maintenance, technical or other support for the Product.

7. CHANGES TO PRODUCT OR AGREEMENT

- 7.1. Vertex Library reserves the right, in its sole discretion, to update or change the terms of this Agreement for the purposes of clarification or the addition and reconfiguration of license types. The most current version of this Agreement will supersede all previous versions and your continued use of the Product will constitute acceptance of any amendments. Vertex Library encourages you to periodically review this Agreement to stay informed of updates to the licensing terms.
- 7.2. Vertex Library reserves the right to suspend sale of or modify the Product (or any part thereof) at any time or from time to time, with or without prior notice to you. Without limiting the foregoing, Vertex Library may provide notice of any such changes to the Product by posting them on its websites, online discussion groups and/or via the email supplied during purchase of the Product. You agree that Vertex Library shall not be liable to you or any third party for any modification to the Product. You acknowledge that Vertex Library has no express or implied obligation to provide, or continue to provide, the Product, or any part thereof, now or in the future.

8. GOVERNING LAW

This Agreement shall in all respects be governed by and construed in accordance with the laws in force in Victoria, Australia. If any provision of this Agreement is found to be invalid or otherwise unenforceable, the further conditions of this Agreement will remain fully effective and the parties will be bound by obligations which approximate, as closely as possible, the effect of the provision found invalid or unenforceable, without being themselves invalid or unenforceable.

9. TERM AND TERMINATION

This Agreement takes effect upon purchasing and/or making use of the product and remains effective until terminated. You may terminate it at any time by destroying all copies of the product and included files and deleting all files and copies thereof from your hard disk. It will also automatically terminate if you fail to comply with any term or condition of this Agreement.
